**IT IS HEREBY ORDERED THAT:**


1. In accordance with section 14 (4) of the Terrorism Prevention Act, the following entities, designated as terrorist entities by the United Nations Security Council and who were added or whose information was amended on the United Nations Sanctions List under reference number SCA/2/20(15) dated September 10, 2020, are hereby declared as listed entities for the purposes of the Terrorism Prevention Act:

- a. QDi.096 Name: 1: MOUSSA 2: BEN OMAR 3: BEN ALI 4: ESSAADI.
- b. QDi.099 Name: 1: KHALIL 2: BEN AHMED 3: BEN MOHAMED 4: JARRAYA.
- c. QDi.138 Name: 1: SAID 2: BEN ABDELHAKIM 3: BEN OMAR 4: AL-CHERIF.
- d. QDi.139 Name: 1: IMED 2: BEN MEKKI 3: ZARKAOUI.
- e. QDi.140 Name: 1: KAMAL 2: BEN MAOELDI 3: BEN HASSAN 4: AL-HAMRAOUI.

2. In accordance with section 6(1) of the Terrorism Prevention Act, no person in Jamaica and no Jamaican outside Jamaica shall knowingly:
  - a. deal directly or indirectly in or with any property that is owned or controlled by or on behalf of the above-mentioned listed entities.

- b. enter into or facilitate, directly or indirectly, any transactions in respect of property that is owned or controlled by on behalf of the above-mentioned listed entities.
  - c. provide any financial or related services in respect of that property that is owned or controlled by on behalf of the above-mentioned listed entities
  - d. convert any property owned or controlled by or on behalf of the below mentioned entities or take any steps to conceal or disguise that the property is owned or controlled by or behalf of the above-mentioned listed entities.
  - e. This Order remains in effect except or until an Order is made the Court for any exemptions in accordance to section 14 (B) and 14 (C) of the **Terrorism Prevention Act**.
3. The Applicant's attorney is to prepare, file and serve a copy of the Order along with a copy of SCA/2/20(15) dated September 10, 2020, issued by the United Nations Security Council Sanctions List Committee on all relevant authority and financial institutions.
