  - b. All Orders previously issued by this Court in respect of the below mentioned listed entities shall cease to apply to said entities as of February 22<sup>nd</sup> 2021.
  - c. This Order relates to the following entities whose details are contained in UN document SCA/2/21 (04) dated February 19, 2021: **1. QDi.138 Name: 1: SAID 2: BEN ABDELHAKIM 3: BEN OMAR 4: AL- CHERIF and QDi.362 Name: 1: EMRAH 2: ERDOGAN**
2. The Applicant's attorney is to prepare, file and serve a copy of this Order along with a copy of UN document SCA/2/21 (04) dated February 19, 2021, issued by the United Nations Security Council Sanctions List Committee on all relevant authority and financial institutions.
